

Personal Services Industry Profile in WDB 15 - Ramsey County

There were **239 personal care services establishments** providing **1,508 jobs** in Ramsey County through the 3rd quarter of 2019, according to data from DEED's Quarterly Census of Employment & Wages program. In addition to covered employment, there is a significant amount of self-employment in personal care services, accounting for **1,267 firms** in Ramsey County and more than \$33.5 million in total sales receipts, for an average of \$26,469 sales per firm (Table 1).


Table 2 breaks down covered employment for the total of all industries and personal care services for the Seven-County Metro Area. Specifically, covered employment accounts for all employment at establishments covered under the Unemployment Insurance Program. Self-employment within personal services is also highlighted, as there is a significant amount of such employment within this industry sector.



Workers in the personal services industry are slightly younger than in all other industries combined. As of 2019, over two-fifths (41.5%) of the personal service workforce in Ramsey County was younger than 35 years, as compared to about one-third (33.9%) of total workers in the county being younger than 35 years. There was a smaller share of workers in personal services 45 years of age and older (37.1%) than for the total of all workers (44.0%) in the county (Figure 1).



Personal service workers in Ramsey County are more diverse than the total of all workers in the county. As of 2019, 29.0% of personal services workers in the county identified themselves as other than white. This was compared to 22.0% of such workers for all industries combined (Figure 2 – please note that the numbers add up to more than 100% because Hispanic or Latino is an ethnicity rather than a race).
